PROPOSITIONS CARRIED

Rule: 1.2(ii), Page 26

New Text: The subscription from each club shall be £35.00 per team per annum to be paid not later than 31st May in any year. Any club failing to comply with this rule shall be fined £5.00 for the first month, or part of the month, after this date, and £20.00 for every month, or part of a month, thereafter that the subscription remains unpaid.

Rule: 1.3(i), Page 27

New Text: The officers of the League shall consist of The President, Vice-President, Chairman, Treasurer, Secretary, Fixture Secretary, League Statistician, League Registrar, League Welfare Officer, Press Officer and the Umpires Appointment Secretary, all of whom, with the exception of the President and Vice-President, shall be elected at the Annual General Meeting.

Rule: 2.7(i), Page 33

New Text: (i) All results must be entered on to the BDCL ECB Play-Cricket Website by the home side within 48 hours of the match and confirmed by the away team within a further 48 hours. Scorecards are to be fully entered with all participating players, including the names of players involved with catches and run outs.

For matches played on a neutral ground, the winner shall be deemed the home side.

Any problems relating to the submission of a result or scorecard should be sent to the League Registrar in the first instance for investigation.

A fine of £20.00 shall be imposed for non-compliance.

Rule: NEW – additional rule to 3.3, Page 34

New Text: The Umpires shall have sole authority as to when intervals shall be taken.

Rule 3.5 (iii) amend 20 overs to read 17 overs.

New rule to read as follows;

When a time limit has been applied there shall, unless further interference occurs or the match is completed, be one hours play or a minimum of 17 overs bowled.

Therefore:

Rule 3.5 (iv) amend 20 overs to read 17 overs, and 3 minutes to read 3½ minutes.

New rule to read as follows;

If further interference occurs when a time limit has been applied, or if time lost during the last hour of play causes a time limit to be applied, the number of overs to be bowled on any resumption of play shall be reduced, from the total of 17, by one over for each full 3½ minutes, which have elapsed after the scheduled commencement of the last hour.

Rule 5 – pages 38 to 41

Qualification and Registration of Players

The text regarding the change to this rule is too lengthy for this document. The full wording can be found on pages 60 to 67 inclusive of the current 2013 League Handbook.

RULE CHANGES – 2014 – PROPOSED BY THE LMC

1.

Rule 1.2(ii) to read:-

The subscription from each club shall be £35 per team, per annum to be paid no later than 31st March in that year.....(The change is from the 31st May to the 31st March in the same year).

2.

Rule 3.3(i) Hours of Play – General Information to read:-

Matches shall commence at 1.30pm in April to August inclusive and at 1.00pm in September. (Championship – at 1.30pm in April to July inclusive, at 1pm in August and at 12.30pm in September). Clubs may, if they so desire, start earlier if they mutually agree, the Umpires Appointments Secretary must be informed.

3.

Rule 2.4(iii) Fixtures to read:

Each club shall fulfil its fixtures with teams selected in compliance with the following criteria:

‘On all dates, no player shall be eligible for a team more than one lower than that for which most, or equal most, appearances have been made during the current season.

Additionally, in a fixture played after the third Saturday in August, on a Bank Holiday Monday, on a Sunday, or any other date that a more senior team has no fixture, or a fixture cancelled, a player who has only appeared at a higher level than the match being played, shall not be eligible to play’.

Note from the LMC re the above: The Championship will conclude its fixtures, one week earlier than all other Divisions from season 2014. The League Secretary will add more detail to this in his report.

RULE CHANGE – 2014 – PROPOSED BY OLLERTON COLLIERY CC

4.

Rule 2.5 – Cancellation of Matches to read:

Current Rule

Rule 2.5 (vi)

Any club failing to fulfil a League engagement may be fined £20.00 and shall have ten points deducted from the total of the team concerned. The game shall be counted as a win, with full bonus points, for their opponents.

Proposed New Rule

Rule 2.5 (vi)

Any club failing to fulfil a League engagement shall be fined £20.00 and shall have ten points deducted from the total of the team concerned.

In the event of a second occurrence during the same season the club shall be fined £50.00 and have 20 points deducted from the total of the team concerned.

In the event of a third occurrence during the same season the team concerned shall be automatically relegated at the end of the season and in the event of a team in the lowest division shall be expelled from the league, but be eligible to apply for re election to the league.

In all occurrences the game shall be counted as a win, with full bonus points, for their opponents.

RULE CHANGE – 2014 – PROPOSED BY WHITWELL CC

5.
League rule 5.2(iii), which relates to the registration of overseas players, currently contains the following paragraph:

'An Overseas Player must be aged 23 or under on 1st April prior to the season for which he is first registered and is then eligible to play for the same club each consecutive season.'

Whitwell Cricket Club proposes that the above paragraph be deleted from the league rules, therefore removing the age restrictions associated with overseas players.

The LMC wish to gain the support of all clubs to establish the below simple and basic Constitution of the BDCL for the years ahead.

League Constitution

Name

The Bassetlaw & District Cricket League

Purpose

To foster and promote participation in the sport of Cricket within the Bassetlaw community and surrounding districts. To organise cricket clubs who wish to participate into an appropriate number of Divisions plus Cup Competitions and to manage these competitions and arrangements.

Affiliation

The League requires that all clubs playing in the Bassetlaw & District Cricket League are affiliated to the England and Wales Cricket Board through a County Cricket Board.

The League requires that its member clubs shall ensure that members abide by the Laws of Cricket and playing and non-playing members abide by the Leagues Code of Conduct which incorporates the Spirit of Cricket.

The League requires that all its member clubs shall adopt and implement the ECB 'Safe Hands – Cricket's Policy for Safeguarding Children' and any future versions of the policy.

The League requires that all its member clubs shall adopt and implement the ECB Cricket Equality Policy and any future versions of this policy.

Finance

The BDCL is a not for profit organisation and subject to these Rules, the LMC shall have the responsibility for the management of all its funds, property and affairs.

Winding-up

The members may vote to wind up the League at a properly convened Annual General Meeting or Extraordinary General Meeting. Three quarters of all member clubs shall form a quorum.

- (i) The LMC will be responsible for the orderly winding up of the League's affairs.
- (ii) After settling all liabilities of the League, the LMC shall dispose of the net assets remaining to one or more of the following:
 - a) To another League with similar sports purposes which is a charity.
 - b) Equally to clubs within the League with similar sports purposes which is a registered CASC.
 - c) To the League's national governing body for use by them for related community sports.
