# 4. Matters arising:

4 1

Thoresby Park had notified the League that they wished to only have one team in the League and to take up their rightful position in Div 2 in 2011.

**DECISION:** Agreed for the 2011 constitution. Thoresby Park CC would have one team in Diy 2.

4.2

The Secretary updated the meeting on a lengthy summary regarding the registration of a player for West Indian Cavaliers CC in their last game of the 2010 season v Blidworth CC. This registration involved cricket clubs in Scotland, Derbyshire and Liverpool. Additionally, evidence from West Indian Cavaliers was also read to the meeting who discussed and assessed the situation.

**DECISION:** No further action should be taken against any club or any player. The League Secretary was thanked for his work with this matter.

#### 4.3

Confirmation had been received that there would be no change to the two clubs Roses and Lea Park for season 2011.

Confirmation had been received that Manton CC would be playing once again at Thurcroft for the 2011 season.

4.6

An Appeal Hearing in relation to a player from Caythorpe CC, Andrew Staszkiewicz, had imposed the following penalty on the player:

- A 4 week suspension from playing in all cricket (23<sup>rd</sup> April 2011 to 20<sup>th</sup> May 2011 inclusive)
- A further 4 week suspension from playing, suspended until the end of the 2011 season
- Caythorpe CC 2<sup>nd</sup> Xl to be deducted 8 points from their 2010 Div 1 total
- The player to write a letter of apology to both the league and the victims of his behaviour at Ransome & Marles CC.

A Disciplinary Hearing had imposed the following penalty upon Rollo Sharma, a player for Welbeck CC 2<sup>nd</sup> Xl in the last game of the season on the 11<sup>th</sup> September 2010:

- A 4 week suspension from playing in all cricket (23<sup>rd</sup> April 2011 to 20<sup>th</sup> May inclusive)
- Welbeck Colliery CC 2<sup>nd</sup> Xl in Div 1 be deducted 4 points from their 2011 total

5.3

A meeting had been planned between the NCB PL, SNL and the BDCL to take place at Kimberley CC on Thursday 28<sup>th</sup> October 2010. The Secretary read the content of the agenda for this meeting.

Mansfield & Pleasley CC wished to nominate Chris Revill, the Chairman of their club for a place on the LMC for season 2011.

9.1

Martin Cannon summarised the BDUA AGM, regarding standards of changing facilities at various clubs, assessment of umpires throughout the season and the planned umpire training during the winter.

9.2

- Meeting at Trent Bridge regarding the Managed Migration Policy
- Meeting of the League Cricket Conference at Cuckney at the end of September. (The Minutes are to be circulated in due course)
- Meeting of the Senior Cricket Board Committee. Matters at this meeting involved Clubmark status to Kiveton Park Colliery CC, the Champion of Champions match at Cuckney at the end of the season.
- The Away Day at Trent Bridge of the Nottinghamshire Cricket Board had been postponed

9.3

The Chairman updated the meeting on a previous meeting held at Worksop Cricket Club between members of the LMC and members of the BDUA management team. This meeting was the first of what was hoped would be an annual meeting at the end of each cricket season. The meeting primarily discussed and agreed, various ways in which the disciplinary processes could be improved. A letter from Peter McKenzie in relation to suspended bans being imposed upon players linked in with the discussions. Additionally, the Secretary read to LMC a letter from Ervin Devney an umpire, regarding a recent disciplinary hearing and its outcomes. The LMC debated the facts and listened to people's opinions.

**DECISION:** The content of all meetings were noted and acknowledged. Additionally, the Secretary was asked to reply to Ervin Devney in keeping with the outcome of the review of the said disciplinary meeting.

#### 10. BDCL Vice President – 2011

The meeting discussed the need to elect the Vice President for 2011 and subsequent President for 2012.
