2. ACCEPTANCE OF MINUTES FROM THE PREVIOUS MEETING

The minutes of the meeting held on **Tuesday 12 June 2018** were accepted as a true and accurate record of proceedings.

3. MATTERS ARISING FROM THE PREVIOUS MEETING

3.1 NF reported that a matrix detailing which members of the LMC have permission to edit the league web sites and social media accounts and the level of access has now been updated as agreed at the last meeting.

4. FINANCE & SPONSORSHIP

4.1 League Accounts. TM gave a summary of the current financial position and answered any questions relating to the accounts. The current bank balance stands at £9306.93, cash in hand is currently £4.28 giving a total of £9311.21 as at the meeting date.

The balance continues to reflect a healthy financial position. TM added that there had been a significant increase in income from fines imposed on clubs – most of these have been paid but there are still some outstanding.

There was additional expense incurred during June for the trophies for the Mallen 20-20 cup competition. Payments were also made to Retford CC and Cuckney CC for facilitating Child Welfare Training Courses.

GJ, on behalf of the LMC, thanked Trevor Haywood for his work in purchasing and organising the trophies for the Mallen 20-20 Competition.

4.2 GB reported that the BDUA are in the process of undertaking a significant number of formal umpire assessments during the 2018 season; and asked if the league would contribute towards the cost of expenses for the assessors involved.

Following a discussion, it was agreed that the BDCL will contribute £150.00 in support of the BDUA umpire assessment programme.

5. CHILD WELFARE AND DBS MATTERS

- 5.1 AV reported that he had now received final confirmation that all club welfare officers can be authorised as DBS verifiers. Josh Scully at the Nottinghamshire Cricket Board will initiate the process; AV will circulate all necessary information to the Nottinghamshire & Yorkshire Cricket Boards.

GJ thanked AV on behalf of the LMC for bringing this matter to a satisfactory conclusion; this should make obtaining DBS verification for those requiring it within our league clubs a more convenient and straightforward process in future.

6. CORRESPONDENCE

- 6.1 NF reported that the June meeting of the NPL had been cancelled; and that the July meeting was being held concurrent with the BDCL meeting tonight; therefore, he had submitted apologies. The minutes from the July meeting will be circulated once received.
- 6.2 An e-mail has been received from CACCC regarding the responsibility for forfeiture of their fixture with Blidworth Colliery Welfare CC on Saturday 7 July. No explanation has yet been received from Blidworth due to key personnel being on holiday; this is awaited and a decision on allocation of points and any sanctions to be applied will be made following receipt of this information.
- 6.3 An e-mail has been received regarding expenses payments for one of the umpires who arrived at the Blyth II CC v Retford II CC fixture on Saturday 7 July, only to find that the match had almost finished. It was decided that the league secretary should write to Blyth CC to seek an explanation of the circumstances (including whether the umpire in question had been informed of the early start) before a decision is taken on who should take responsibility for paying the umpires expenses.
- 6.4 Umpires Reports. Six **BDCL Recreational Umpire Disciplinary Reports** have been received since the last meeting as detailed below.

- 6.5 An e-mail has been received from Misterton CC regarding the points allocation from their conceded fixture at South Normanton CC on Saturday 7 July. Despite the best efforts of Misterton to play or rearrange the fixture, they ultimately had to cancel. After discussion the LMC ruled that Misterton had forfeited the fixture and would therefore be subject to the normal sanctions applied for being unable to fulfil a league fixture.
- 6.6 Correspondence has been received from Mansfield Hosiery Mills CC and Lea and Roses CC regarding the fixture scheduled for Saturday 7 July. The usual venue for MHMCC III (Kingsway Park) was not available and despite efforts from both sides no acceptable alternative or neutral venue could be agreed found. After discussion the LMC ruled that MHMCC III had forfeited the fixture and would therefore be subject to the normal sanctions applied for being unable to fulfil a league fixture.
- 6.7 A letter has been received from Harthill CC querying the points allocation for matches rearranged from 7 July to August Bank Holiday Monday (27 August).

It was noted that the original e-mail offering options for 7 July stated that '[Any fixtures that have been rearranged to 27 August \(Bank Holiday Monday\) or are in the process of being rearranged will be played under ALL normal league rules. Thanks to all the clubs that have taken or are taking this step.](#)'

As this information had been clearly circulated to all clubs, the LMC confirmed that all league fixtures on this date would be covered by normal league rules, including allocation of points.

- 6.8 An e-mail has been received from the captain of Papplewick CC III querying the eligibility of certain Aston Hall CC III players and various other concerns during their division 5 match on Saturday 30 June 2018. League officials subsequently investigated the matter and asked Aston Hall CC for their comments regarding the issues raised. The LMC found that no league rules had been breached and therefore no case to answer.
- 6.9 NF reported that he had forwarded the e-mail from the NCB secretary to championship division club secretaries. A 2019 NPL eligibility pro forma was attached to the e-mail which the clubs concerned have been requested to complete and return to Ian Smith by 30 July.

7. CLUB CONSULTATION PLANS 2018 (RULES COMMITTEE)

- 7.1 SR reported that Carl Lake of Rockware CC had not been able to attend the last rules committee meeting but had reviewed proposed changes and made comment/suggestions for change via e-mail.

75 proposed amendments/deletions/queries have been made so far and more are being discussed. The next meeting is scheduled to be held at Edwinstowe CC on 25 July 2018.

A draft document will be made available to the LMC to discuss and review during the next August 2018 meeting.

SR suggested that a pre-AGM meeting to discuss the proposals be held in October. Monday 8 October was agreed as a suitable date, NF to ascertain the availability of the facilities at Cuckney CC on that evening.

It is envisaged that clubs will be asked to send at least one player representative (not holding a position on a club committee) to this meeting to give a player's perspective, their views and suggestions can then be considered prior to a final draft version of the rules being prepared for presentation at the league AGM in November.

8. ANY OTHER BUSINESS

It was agreed that the standard sanctions would be applied to the teams who conceded, which are:

- **A 10-point deduction from their league total**
- **20 points awarded to their opposition**
- **A £10 fine; which will be repaid to their opposition by means of a reduction in their annual league subscription for the following season.**

- 8.3 BDUAs. GB reported that the next BDUAs meeting will be held on Thursday 12 July.
- 8.4 GDPR. GB stated that several umpires had asked what steps the LMC had taken in respect of GDPR. NF reported that Michael Carlisle has produced a league GDPR guidance document, this will now be circulated ready for discussion and adoption at the AGM.

It was noted that postal addresses have been removed from the on-line edition (BDCL Web Site) of the 2018 league handbook.

- 8.5 Mollen Trophy. GJ reported that despite the problems encountered at the league stage, the competition had reached a successful conclusion.

The final was keenly contested, with Ordsall Bridon CC eventually coming out on top against Welbeck CC in the final.


The LMC congratulated Ordsall Bridon CC on their victory and thanked Clipstone-Bilsthorpe CC for hosting the final and Glapwell CC for hosting the second semi final match.

Ordsall Bridon CC went forward to the feeder league 20-20 final at Edwinstowe on 7 July to face Gedling Colliery CC who were the eventual winners in a keenly fought contest.

- 8.6 Promotion from BDCL Championship to NPL. It was noted that the team to be promoted would either be the winner or runner up of the Championship Division as stated in the current NPL rules.
- 8.7 Annual Dinner. RM reported that preliminary arrangements had been made by himself and Janet King. However, RM added that due to holiday arrangements he would not be attending the 2018 league dinner.
- 8.8 League statistics. SR requested that championship and division 1 clubs not using electronic scoring arrangements report any significant batting partnerships via the highlights section on Play-Cricket or via e-mail so that they can be communicated to clubs via the league social media outlets and included in the end of season statistics review.
- 8.9 Andrew Wilson has e-mailed all clubs requesting that they nominate long serving club members for the annual ECB OSCA awards.
- 8.10 Andrew Wilson reported that there may be some complimentary tickets for forthcoming T20 matches at Trent Bridge made available to BDCL clubs; further information will be distributed via individual club secretaries.
- 8.11 M Daniels reported that he will be standing down as a member of the LMC and the position of Vice Chairman. It was agreed that this would take effect after the August 2018 meeting as G Jones will not be available to Chair the August meeting. A new vice chairman will be elected at this meeting.

G Jones thanked Malcolm on behalf of both the LMC and league clubs for his service to the league, particularly the duties he had carried out representing the league at NCB meetings and the work he had carried out on the BDCL Web Site.
