2. ACCEPTANCE OF MINUTES FROM THE PREVIOUS MEETING

The minutes of the meeting held on **Tuesday 14 August 2018** were accepted as a true and accurate record of proceedings.

3. MATTERS ARISING FROM THE PREVIOUS MEETING

- 3.1 NF reported that Mansfield Hosiery Mills CC had requested that the LMC review their decision to award full match points to Lea & Roses CC II following the cancellation of the fixture scheduled for 7 July. The LMC reviewed the circumstances and considered the previous instance where a similar situation had occurred, following which it was unanimously agreed to uphold the decision of the LMC and the resultant sanctions.
- Quality of cricket balls. A number of concerns and complaints have been received from clubs regarding the poor quality of Readers cricket balls used throughout all divisions of the league. AR added that the balls from all the three grades prescribed for use in the league were of poor quality.

TM reported that there is one year left on the current deal with Readers; and that a meeting had been arranged with Neil Pullen to discuss the matter of cricket ball quality, however he had not been able to attend due illness.

AR suggested a trial period be held in 2019 for Championship/Division 1 clubs to try balls from different manufacturers (Dukes etc), with information fed back to the league in a formal manner for evaluation prior to seeking a new sponsorship and supply contract.

This was agreed and will be placed on the agenda for further discussion at the October meeting. NF to contact the NPL to ascertain their contact for supply of Dukes cricket balls; TM will then follow this up and propose a trial programme and time for the different balls selected.

3.3 GB reported that following a recent meeting, he had agreed to remain as secretary of the BDUA and as a Bassetlaw League umpire. G Graney will also remain in post to co-ordinate the BDUA assessment programme and undertake umpire assessments.

4. FINANCE & SPONSORSHIP

4.1 League Accounts. TM gave a summary of the current financial position and answered any questions relating to the accounts

TM added the following comments:

- The end of the financial year is 30 September 2018.
- All expenses claims must be submitted and paid by this date.
- Honoraria payments have now been agreed and will total just below £2000.00
- Fines have been issued for all games conceded up to 18 August, any remaining will be invoiced immediately following the end of the season.

It was also unanimously agreed that the Chairman should be allowed to claim travel expenses for attendance at other meetings when representing the league. The number of meetings requiring the presence of LMC members has increased significantly over the last twelve months. TM to provide GJ with the appropriate expenses claim form.

5. CHILD WELFARE AND DBS MATTERS

5.1 AV reported that progress has been made with establishing CWO's as on-line DBS verifiers. Some initial difficulties had been encountered, but two have now been completed and the intention is to complete the process in batches of six throughout the winter period.

6. CORRESPONDENCE

6.1 NF reported that correspondence had been received from South Normanton CC requesting that the league examine the possibility of introducing a player loan system.

It was noted that this has not been considered by the rules committee. However, this matter will be tabled for discussion at the pre-AGM and the AGM. NF undertook to gather information on player loan systems by other local recreational cricket leagues for distribution and discussion accordingly.

6.2 NF reported that Glapwell Colliery CC had submitted an e-mail regarding the lack of scorers and potential additional rewards for teams in the championship division where only one **official** scorer is present at a match.

After discussion the LMC agreed that it was unethical for the proposal made by Glapwell CC to be taken forward. However, the correspondence was passed to the rules committee for further consideration, and Glapwell CC have been asked to consider alternative proposals for submission as potential rule changes prior to the AGM.

6.3 Umpires Reports. Nine **BDCL Recreational Umpire Disciplinary Reports** have been received since the last meeting as detailed below.

7.1 SR reported that following a debate on the proposals at the August LMC meeting, several tweaks have been made prior to presentation at the pre-AGM meeting.

It was agreed that minor edits/clarifications/removal of defunct regulations would be presented as an 'en block' proposal at both meetings, to allow enough time for the major changes to be debated.

It was agreed that the standard sanctions would be applied to the teams who conceded, which are:

- A 10-point deduction from their league total
- 20 points awarded to their opposition
- A £10 fine; which will be repaid to their opposition by means of a reduction in their annual league subscription for the following season.

8.4 BDUA.

GB reported that an umpires meeting had been held on 10 September 2018, and:

The number of umpires available for championship division fixtures next season will be reduced.

Three umpires have been selected possible promotion to the NPL list for the 2019 season.

GB thanked clubs in the championship and division one for their contributions to the umpire assessment process.

The BDUA 70th Anniversary Dinner will be held at Worksop Golf Club on Saturday 3 November; Steve Garrett will be the guest speaker.

8.5 A disciplinary hearing in respect of a level 3 offence by W Parker of Welbeck CC was held at Worksop CC on 22 August 2018. A sanction of a 2 week ban from all forms of cricket was imposed, commencing from Friday 25 August; with a further 4 weeks suspended until the end of the 2019 season. All local cricket boards were notified of this matter.

It was noted that although the disciplinary meeting had been rearranged to accommodate the umpires, neither umpire who officiated at the match attended the hearing.

- 8.6 Fixtures for 2019 season. A meeting will be arranged with the SNCL and the NPL as necessary to discuss the arrangements for fixtures in 2019. It is hoped that some rearrangement of the NPL Bank Holiday fixtures can be made, which will avoid the current situation where there is a repeat fixture for BDCL teams on the last two weeks of the season. NF to raise this matter at the next NPL meeting (12 September).
- 8.7 Promotion to the NPL. It was noted that it is unlikely that Clipstone & Bilsthorpe CC will be permitted entry into the NPL. This being the case, the invitation to compete in the NPL during 2019 will be extended to Notts & Arnold Amateurs CC, who look likely to finish as runners up in the Championship Division.

Further information on this will be made available once league positions are finalised. Other promotion and relegation issues will be confirmed when the composition of the championship division has been agreed, and all other relevant factors (e.g. teams merging/restructuring, teams moving to other leagues, effects of any rule changes to the number of teams per division, total number of divisions etc) are known to the LMC.

- 8.8 League Vice Chairman. A vacancy as vice chairman has arisen now that Malcolm Daniels has stood down as a member of the LMC. GJ reported that he had asked David Parnham to undertake the role, David has now accepted; this appointment was then duly ratified by the LMC.
- 8.9 Annual Dinner, Saturday 17 November. RM reported that the League caps for presentation on the night have been organised, and that he would be liaising with Julie English at South Forest to confirm prices.
 - GJ undertook to organise a guest speaker for the evening.
 - GJ & TM will MC during the dinner in the absence of RM.
- 8.10 LMC vacancies. There is already one vacancy on the LMC and further vacancies may become apparent before the AGM.

One application has already been received, all clubs are encouraged to nominate club members to sit on the LMC as is their right under league rules. This will be restated at the forthcoming pre-AGM. If more applications are received than available vacancies, then a vote will be taken at the AGM.
