2. ACCEPTANCE OF MINUTES FROM THE PREVIOUS MEETING

The minutes of the meeting held on **Tuesday 08 January 2019** were accepted as a true and accurate record of proceedings.

3. MATTERS ARISING FROM THE PREVIOUS MEETING

- 3.1 Cricket ball order form. NF reported that the 2019 cricket ball order form has been distributed to clubs and will be uploaded to the web site.
- 3.2 BDCL Website. NF reported that development of the web site had almost been completed. GJ, TM and NF had visited b4-6 on 11 February for a preview/demonstration and administrative training. A usage agreement has now been signed with the ECB to permit the fixtures and league tables to be uploaded.

Web site development should be completed and signed off by the next LMC meeting, by which time nominated site administrators should have passwords and appropriate levels of access.

- 3.3 Fixtures. All league fixtures have now been agreed, confirmed and uploaded to the BDCL Play-Cricket Web Site.
- 3.4 Tiflex Ball Trial. TM has received the 24 Tiflex balls for the trial involving Championship and Division 1 teams during the forthcoming season.
- 3.5 NF confirmed that a letter of appreciation has been sent to Robert Bramham.

4. FINANCE & SPONSORSHIP

4.1 TM had forwarded a set of accounts to be presented in his absence. The invoice for the 2018 Annual League Presentation Dinner has been paid in full, with a consequent effect on the balance sheet.

The balance will be redressed by the income from club subscriptions, the invoices for the annual subscriptions have been e-mailed to clubs with a payment due date of 31 March 2019.

The league insurance policy for 2019 has been paid; the cost was £60 less than in 2018.

5. CHILD WELFARE AND DBS MATTERS

5.1 A Wilson reported that CWO courses are being held at Edwinstowe CC on 7 and 12 March 2019. These are free to BDCL clubs and details have been circulated via e-mail and can be booked via the links on the Nottinghamshire Cricket Board web site (www.nottscricket.com/page/clubs/safeguarding/safeguarding).

A Wilson added that most Nottinghamshire clubs are now fully covered, and a further update will be given at the next meeting.

5.2 A Vollans reported that he now has a full list of club e-mail addresses and will continue to contact BDCL clubs and strive to ensure that each one has at least two DBS verifiers.

6. CORRESPONDENCE

6.1 NF reported receipt of letters from Kiveton Park Colliery CC and Todwick CC regarding using up existing stocks of BDCL approved cricket balls.

Although Readers League Special ball will not be on the BDCL list of approved balls for 2019, clubs will be permitted to use up stocks of League Special balls as soon as possible during the early part of the 2019 season.

League stamped Reader Sovereign and Reader County Match balls will also be permitted as in previous seasons, together with the Reader Special County Crown ball.

7. CLUB CONSULTATION PLANS 2018 (RULES COMMITTEE)

7.1 SR reported that the rules committee will consist of a maximum of 6 members and recruitment for new members is ongoing.

Martin Cheshire will continue as a member of the rules committee; however, Gary Bardill will stand down.

A meeting will be arranged before the end of March 2019, with further meetings to be arranged for the fourth Wednesday of each month. The meetings will continue to be held at Edwinstowe CC.

8. ANY OTHER BUSINESS

8.1 JL reported that so far, he has only been able to allocate umpires down to division 4. No umpires have been allocated yet for fixtures in divisions 5, 6, and 7; although this may change if umpires become available at short notice.

AR has put two recently qualified umpires in contact with John Leaning.

8.2 GB reported that:

three more BDUA umpires have graduated to the NPL list and will participate in four matches each.

A stage 3 umpire training course will be held over a four-week period in March/April 2019 at Edwinstowe CC. The course is fully subscribed.

In memory of the contribution that Brian Rivington made to Bassetlaw League cricket, the BDUA have discussed the introduction of a fair play award for the Championship and Division 1 commencing this season. This was backed by the LMC and it was agreed to implement the award from the forthcoming season.

The BDUA will progress the idea through their management committee and will take responsibility for the administrative process throughout the season.

- 8.3 NPL Division 2. NF reported that there had been no further updates since the last NPL management committee meeting. The next NPL meeting is 13 February and any developments will be reported as soon as possible thereafter.
- 8.4 2019 Mallen Trophy competition. The draw was made for the group venues and matches (to take place on Sunday 23 June) and the Semi-Final and Final Venues (matches to take place on Sunday 30 June).

Details of the draw will be circulated to competing clubs.

The winners will compete in the feeder league final to be held at Gedling Colliery CC on Tuesday 2 July at 6.15 pm (with reserve dates of Wednesday 3 and Thursday 4 July).

- 8.5 2019 League Vice President. GJ reported that Alan Vollans has accepted the role.
- 8.6 2019 League Annual Dinner. No further updates since the last meeting.
- 8.7 Financial contribution to Level 2 coach training courses. AW reported that a level 2 coaching course is being run at Cuckney CC during February and thirteen of the fourteen applicants are from Bassetlaw League clubs; and on behalf of the NCB asked if the league would contribute towards the cost of the course, which is £275 per applicant.
 - Following a discussion, it was agreed that the league would make a minimum contribution of £250 towards the total cost, this will be reviewed again at forthcoming LMC meetings. GJ will also approach the BDJCL committee regarding provision of at least an equivalent donation.
- 8.8 2019 League Handbook. The number of league handbooks to be ordered is under review, as it had been noted that a significant number had not been distributed last season. A further update on will be given at the next LMC meeting. In the meantime, Ratcliff & Roper printers have been asked to provide a quotation for 500 handbooks.

- 8.9 Team Cards. The BDCL team cards (as provided for the 2018 season) will be used again during the 2019 season. This will use up current stocks and a decision about which team cards will be used in future will be made at the end of the season.
- 8.10 AW reported on the Nottinghamshire Cricket Board club forums being held throughout the county during February; one of which will be held at Cuckney CC on 27 February.

Sue Redfern of the ECB will be in attendance, and possibly Mick Newell or Matt Wood from Nottinghamshire CCC.

The events are open to all clubs; AW urged all clubs to attend – it is hoped that there will be three attendees from each club comprising players/officials/members/supporters. All clubs have been contacted via e-mail containing a link to the registration process.
