2. ACCEPTANCE OF MINUTES FROM THE PREVIOUS MEETING

The minutes of the meeting held on **Tuesday 9 July 2019** were accepted as a true and accurate record of proceedings.

3. MATTERS ARISING FROM THE PREVIOUS MEETING

- 3.1 NF confirmed that he had written to Cavaliers & Carrington CC to remind them of their responsibilities with respect to the provision of teas.
- 3.2 Cricket ball trials. The trial planned of G&M balls planned for Saturday 27th July had not taken place as the weekend was a washout. The reverse fixtures are scheduled for Saturday 24th August therefore the trial has been rescheduled for that date.
- 3.3 TM reported that he has obtained 12 x Tiflex 'Windsor' balls. It was agreed that these will be trialled in the championship division fixtures on Saturday 31st August. Some balls were passed to club contacts at the meeting; NF will distribute the remainder and inform championship club secretaries of who has collected the balls; accompanied with a reminder to complete and return the ball trial evaluation form to the league secretary for each of the balls trialled in order that quantitative assessments of ball quality and performance can be made.

It was noted that should the league remain with Readers balls for the 2020 season, there will be an increase in the cost of the Readers Special County Crown ball to league clubs.

- 3.4 NPL 2. T Haywood reported on the NPL 2 presentation delivered by Andy Hunt to BDCL Championship Division clubs at Thoresby Colliery CC on 1 August 2019.

The presentation included a comparison with the structure of recreational cricket in other local counties.

Five league clubs attended, and apologies were received from Whitwell CC.

Some compromises will be made on entry requirements into the proposed division 2, including:

- ▶ Clubmark – potential 2 years to achieve, a lighter introductory version (possibly 'Notts Mark') may be implemented as a stepping-stone to achieving full ECB Clubmark status – however full Clubmark must be achieved to play in Division 1.

- ▶ NPL will have 2 Divisions of 10 teams.
- ▶ Cup competition mid-season.
- ▶ 2 teams promoted into NPL 1 from NPL 2, 2 relegated from NPL 1 into NPL 2, relegation from NPL 2 to feeder leagues as currently in place.
- ▶ Ground size restrictions will be relaxed.
- ▶ Any club currently playing in the BDCL or SNCL will be allowed in.
- ▶ Second teams will be allowed in (but not permitted to play 'professionals')
- ▶ Voting will be by Championship/SNCL Division A Clubs – for response by end of September, followed by voting by current NPL teams.
- ▶ It is proposed that 4 teams from the BDCL championship division and 4 teams from division A of the SNCL together with the 2 relegated teams from the existing NPL will form the inaugural division 2 at the start of the 2021 season.

4. FINANCE & SPONSORSHIP

4.1 TM reported that the current bank balance is £8105.50.

- * £160 has been paid to umpires for officiating in the Mallen Trophy semi-finals and final, and the feeder leagues 20-20 play off final.
- * D Parnham has been reimbursed for dealing with expenses claimed by attendees at recent disciplinary hearings.
- * NCB affiliation fees have now been paid.
- * The current league balance is £8105.50; further income totalling £2250 is expected from league sponsors, MKS Groundcare have already paid £100.00.
- * Honoraria and expenses are due to be paid at the end of the financial year, the final balance is expected to be around £8000.00.

4.2 It was noted that the NCB will cease to exist following the AGM in January 2020, and its role will be taken over by the County Club. Further details regarding structure, responsibilities and financial arrangements are unknown at this stage.

5. CHILD WELFARE AND DBS MATTERS

5.1 There were no reports or updates from the NCB due to A Wilson being on holiday.

5.2 Following a recent disciplinary hearing it was agreed that league clubs need to be reminded of the ECB policy on adults and children changing in the same rooms; the league secretary undertook to circulate the relevant document to our clubs; this can also be viewed as below:

5.3 It was noted that two of the recent league disciplinary hearings involved players under 18 years of age; details of the outcomes will thus remain confidential. The details will be submitted to county club boards as is the agreed practice but will not be published in the public domain.

6. CORRESPONDENCE

It was agreed that the standard sanctions would be applied to the teams who conceded, which are:

- **A 10-point deduction from their league total**
- **20 points awarded to their opposition**
- **A £10 fine; which will be repaid to their opposition by means of a reduction in their annual league subscription for the following season.**

- 6.3 Umpires Disciplinary Reports. Reports received since the last LMC meeting and actions subsequently taken by the league disciplinary sub-committee are summarised below:

Two hearings were also held involving league players under 18 years of age.

- 6.4 TM reported on a query raised over the registration of a Waleswood player involved in the division 4 fixture at Misterton CC on Saturday 3 August 2019. Following submissions of evidence and an investigation carried out by TM, the LMC ruled that Waleswood Sports CC had fielded an unregistered player and will therefore be fined £10 and have 10 points deducted from their divisional total. The 20 match points were awarded to Misterton CC (rule 5.6.3).

The player involved has now been correctly registered and is permitted to play for Waleswood Sports CC for the remainder of the 2019 season.

- 6.5 NF reported that a newly formed club, Carlton CC, has made an application to join the league.

In accordance with league rules they have been requested to make a £30 payment to the league by the October 2019 meeting and look to provide a league umpire to officiate in the league next season from within their resources. The league secretary will extend an invitation to the club to attend as observers (without a vote) to the pre-AGM and the 2019 league AGM.

NF added that he had stressed to Carlton CC that it is essential that they appoint a suitable club member as their club welfare officer, and that the appointee obtains an ECB DBS and attends the appropriate ECB CWO courses in good time for the start of the 2020 season.

- 6.6 NF read out a letter of thanks from GJ for the £500 donation from the league towards the cost of roof repairs on the pavilion at Ordsall Bridon CC.

- 6.7 Observations had been received from Todwick CC in relation to their cancelled fixture against Harthill CC on Saturday 10 August 2019. Following consideration of all the evidence made available, the LMC decision was that no league rules had been broken and the recorded result of 'cancelled' will stand with 6 points awarded to both teams.

- 6.7 An e-mail had been received from Milton CC enquiring as to whether they would be able to loan a player who has occasionally played in the SNCL, they were subsequently advised that this was not possible within current league rules.

- 6.8 An e-mail had been received from Rockware CC regarding the matter of the cancellation of their fixture at Waleswood CC on Saturday 10 August 2019.

After reviewing the contents of the e-mail, the LMC agreed that no verbal agreement had been reached between the two clubs to cancel the match; consequently, Rockware CC were awarded the 20 match points.

Waleswood Sports CC will also be fined £10 and have 10 points deducted from their divisional total. It was also agreed that the BDUA umpire who travelled to the match would be paid £15 travelling expenses from league funds.

POST MEETING NOTE

Subsequent to the LMC meeting, a detailed written submission was received from the Management Committee at Waleswood CC explaining their version of events leading up to the match being cancelled, together with an explanation in a telephone call to the league secretary. The evidence was digested and reviewed by the league referrals committee; following which it was unanimously agreed to uphold the original decision made by the LMC at the meeting on 13 August; and the sanctions agreed will subsequently be imposed.

7. CLUB CONSULTATION PLANS 2019 (RULES COMMITTEE)

7.1 BDCL 2019 Player Survey.

SR distributed some information and statistics compiled following a review of the data gathered from the recent survey. The findings had also been discussed by the Rules Committee at their meeting held on 24 July 2019.

A further brief discussion ensued, and it was agreed that the Rules Committee would reconvene in September to draft proposals for rule changes which will then be put to league clubs for discussion and progression at the pre-AGM in October.

8. ANY OTHER BUSINESS

8.1 Mallen Trophy Competition. It was noted that there are some differences in playing conditions between the BDCL Mallen Trophy and the SNCL Chris Trafford Trophy (pink ball, coloured kits etc). It was agreed that this matter will be discussed following the completion of the 2019 season with a view to harmonising playing conditions and rules for the 2020 season and beyond.

8.2 Annual Dinner. TM reported that all clubs have been notified of the new arrangements for the league annual dinner.

Positive feedback has been received and several tickets have already been requested.

Two mandatory tickets will be sent to all league clubs by e-mail towards the end of August, any club which cannot make use of them will have the opportunity to re-sell them to other clubs.
