2. ACCEPTANCE OF MINUTES FROM THE PREVIOUS MEETING

The minutes of the meeting held on **Tuesday 13 August 2019** were accepted as a true and accurate record of proceedings.

3. MATTERS ARISING FROM THE PREVIOUS MEETING

3.1 Cricket ball trials. NF reported that disappointingly, there had been very limited formal feedback from clubs regarding the quality of the balls trialled in the championship and division one.

Positive feedback has been received on the Tiflex Windsor ball. The responses received for the G & M ball and the Tiflex Buckingham balls also trialled were less favourable.

TM reported that he has been in touch with Nathan Searle of Tiflex and has since received a reply detailing a contract offer for league balls. TM added that he would also contact Kookaburra Readers and invite them to retender, based on a 3-year contract. TM undertook to provide an update and details of the respective offers at the October meeting.

3.2 Dates for meetings in 2020. NF reported that the dates for the 2020 LMC meetings have been agreed and booked at Worksop CC. It was agreed that the starting time for the AGM will continue to be 2.30 pm.

4. FINANCE & SPONSORSHIP

4.1 TM reported a current balance of £8188.15.

TM added that the end of financial year balance should stay around this figure; the payments of officer's honoraria/expenses due will be offset against sponsorship monies due to the league; all of which have recently been invoiced.

TM also stated that he will present a budget forecast for 2020 at the next LMC meeting in October.

4.2 No invoices to clubs for conceded matches have been sent out to clubs since early July; the remainder will be forwarded in bulk at the end of the season; together with any repayment due to clubs.

The costs associated with the 2019 league dinner will be incorporated into the 2020 financial year accounts.

5. CHILD WELFARE AND DBS MATTERS

5.1 There were no relevant reports or updates from the NCB.

Plans are being made to hold CWO training courses in November 2019 and March 2020 at locations in both the North and South of the county; dates and venues are currently being finalised and will be publicised once confirmation is received.

6. CORRESPONDENCE

It was agreed that the standard sanctions would be applied to the teams who conceded, which are:

- A 10-point deduction from their league total
- 20 points awarded to their opposition
- A £10 fine; which will be repaid to their opposition by means of a reduction in their annual league subscription for the following season.
- 6.3 Umpires Disciplinary Reports. Reports received since the last LMC meeting and actions subsequently taken by the league disciplinary sub-committee are summarised below:

Outcome/Notes	Suspension of 4 weeks from Friday 6 th September till end of current season on Saturday 21 st September plus first week of 2020 season (dates to be confirmed). Sentence imposed internally by club and endorsed by BDCL disciplinary sub-committee.

- 6.4 It was noted that three umpire reports detailing incidents of bowlers being withdrawn due to bowling 2 above waist height balls have been received since the last meeting; the contents were noted but no further actions are required.
- 6.5 An umpire's report was received from the Killamarsh Juniors CC v Farnsfield CC II fixture, regarding allegations of a batsman 'stealing a run'. The circumstances were subsequently reviewed, and it was agreed that no laws had been broken; no sanctions were thus imposed.
- 6.6 Correspondence had been received from Ian Smith, NCB Secretary, with regards to the formation of a 'County Wide' disciplinary committee; and to ask whether the BDCL wished to nominate members of its own disciplinary committee to sit on the county wide panel.

Following a lengthy discussion, the following conclusion were reached:

- The BDCL agree with a county wide set of standards for reported disciplinary offences.
- The BDCL currently do not wish to provide members of its disciplinary subcommittee to sit on the proposed county wide disciplinary committee.
- The BDCL perceive the benefits of a consistent and robust system of sanctions applied throughout recreational cricket played in Nottinghamshire.
- The LMC requested that the NF write to Ian Smith and invite him to the October (or November) LMC meeting to discuss this matter further and explain the mechanics of the proposed county wide panel (recruitment, structure, proposed venues etc).

6.7 GJ reported that a meeting had been held on 5 September between representatives of the BDCL and SNCL management committees to discuss the proposed NPL Division 2.

It was agreed that a joint communique from both leagues will be sent to the NPL, to express their concerns regarding this matter, particularly the lack of direct consultation with the individual leagues.

Currently, both league chairman are liaising to compile the letter which when completed will be sent to Chris Revill, NPL secretary.

An update will be given at the next LMC meeting, it is expected that the affected clubs in the BDCL Championship and SNCL Division A will be written to and asked to vote on this matter by the end of September 2019.

6.8 Correspondence has been received from Thoresby Colliery CC regarding disparity between the match results displayed on the BDCL Play Cricket site and the independent BDCL.org website.

NF reported that this matter had been investigated by B-46 IT and corrected; however further incidents of this had been reported since and these will be raised with Sean Kennedy at B46, who is responsible for maintaing the independent league website.

6.9 An e-mail has been received from Grassmoor CC regarding the circumstances leading up to the cancellation of their second XI fixture against Clumber Park CC III on Saturday 30 August 2019.

Grassmoor CC had not received official notification from CPCC that they were unable to raise a side until 12.55 pm.

The standard sanctions have been applied to Clumber Park for conceding the fixture; however, since both umpires had arrived at the ground and match preparations were on going, it was agreed that Clumber Park CC were liable for the full payment of both umpires' fees. TM therefore undertook to invoice Clumber Park CC an additional £90 to pay each umpire their full £45 match expenses.

6.10 An e-mail has been received from Thoresby Colliery CC regarding the wearing of playing apparel not in accordance with league regulations during their championship fixture against Clipstone & Bilsthorpe CC on Saturday 24 August 2019. JL contacted the match umpires who confirmed that there were extenuating circumstances with the player concerned; who was able to change into cricket clothing during a drinks break taken a couple of overs after he had taken the field of play. It was therefore deemed that no further action was necessary

7. CLUB CONSULTATION PLANS 2019 (RULES COMMITTEE)

7.1 NF confirmed that the pre-AGM will be held at Cuckney CC on Monday 14th October at 7.00 pm. All clubs will be informed via e-mail and league Social Media.

Clubs will be asked that wherever possible they are represented at the meeting by a member of their management committee and a current player.

8. ANY OTHER BUSINESS

8.1 Annual Dinner.

TM reported that all clubs will receive 2 tickets, the current limit will be 10 per club; this may change dependent on the number returned from member clubs not requiring any.

TM confirmed with LMC members who would be attending and reviewed the number of invited guests.

GJ undertook to discuss the provision of a guest speaker with Mick Newell of Nottinghamshire CCC.

IR & JL pointed out that this will be the first year that the Brian Rivington Fair Play Trophy will be presented to a club from either the Championship or Division 1. It was agreed that Mrs J Rivington should be invited as a guest of the league to present the trophy; JL to confirm whether Mrs Rivington will be able to attend and report back at the next meeting.

- 8.2 Meeting with BDUA. It was agreed to arrange a further meeting between members of the LMC and the BDUA committee after the BDUA AGM on 5th October, when they will have their new committee in place. Discussions will include arranging these meetings on a more regular basis in future.
- 8.3 Umpire Training Courses.

IR confirmed that the following training coursed have been arranged:

Stage 1 - UMPIRES TRAINING COURSE

Overview of the basic laws, how to apply them and principles of field craft and match management. Gives you the tools to umpire matches at basic recreational level.

8.4 Divisional Structure – 2020 season.

Current positions at the top of each league division were noted were noted together with the position at the bottom of the NPL; a discussion also took place over the number of conceded matches during the season.

It was agreed that the secretary should write to all clubs to assess their intentions and plans for the 2020 season prior to consideration of league structures and organising discussions relating to the formulation of the 2020 fixtures.

- 8.5 AW thanked T Haywood for hosting under 9's cricket on Sundays at Thoresby Colliery CC.
- 8.6 AW reported that several 'insight' surveys are being circulated to league clubs by the NCB these include club facilities and ground preparation/maintenance equipment.
- 8.7 AW reported that over 130 volunteers had attended the NCB 'OSCAS' ceremony held at Trent Bridge on Monday 2 September 2019.

It was noted that Richard Martin had received a Lifetime Achiever award and will now go forward to the National competition which will be held at Lords.
