

Rule Change ①

LMC Proposal in respect of start times.

Comment:

LMC Comment — it is very clear from the survey that players favour earlier start times. Should an earlier start time be agreed a reduction in playing overs may not be considered necessary to achieve the earlier finish times that players also favour; the LMC would still like the following proposal to be voted on.

Rule Change (1)(A) Amendment to this proposal from Clumber Park CC

Rationale: In the wort case of no scorer, players from each team doing the scoring and working with umpires has functioned without incident for many years. The necessity for a scorer adds further to the everescalating match day costs.



Rule Change 8

Proposal from Clumber Park CC – Rule 2.6.3: Remove the rule for both Championship and Division 1

Rationale: This rule is too penal and it is a kick in the teeth for players who work hard to earn points, only to see them removed for administrative reasons that are often beyond their control.

Rule Change 9

Proposal from Harthill CC – Rule 3.5.1 Overs per bowler: Amendment of the rule back to the over allowances as they were prior to the 2019 season. In a 50 over game, this to be returned to the previous 15. In a 46 over game, this to be returned to the previous 13.

Rationale: The requirement for a 5^{th} bowler puts an added strain on clubs playing resources and typically weakens 2^{nd} teams when a player who would bowl a full spell in the 2^{nd} team is now playing 1^{st} team cricket to address the 5^{th} bowler requirement.

CPCC Rule Change Proposals for the BDCL AGM 2019

Summary of CPCC Proposals:

- CPCC Proposal 1 12pm start time
- CPCC Proposal 2 Earlier start time than 1.30pm (with 12.30, 12.45 and 1.00 options) (Note: this proposal will not be applicable if proposal 1 above is approved)
- CPCC Proposal 3 Move to 40 overs per side format
- CPCC Proposal 4 Adopt opt-in or opt-out teas to provide clubs with a choice
- CPCC Proposal 5 New simplified '3 points for a win' system scrap draws
- CPCC Proposal 6 Delays in games (Rule 3.4): Request for LMC to amend to maximise chance of completing
 a full game (e.g. allow for min overs to be reduced from 36 to 20 overs)
- CPCC Proposal 7 Remove the 1 point deduction for having no scorer in the Championship and Division 1
- CPCC Proposal 8 Invite clubs to volunteer to take part in a trial of a potential new BDCL league for the 2020 season (Note: this proposal is subject to the outcome of earlier proposals regarding start times and format and may be retracted by the proposers)

<u>CPCC Proposal 1: 'Endorsing The Player Survey' – 12pm Start Time (Divs 1-7)</u>

In the recent player survey **88%** of players expressed a preference to start earlier, with **53%** wanting to start at 12pm or before. Among players under 30 years of age, this figure increases to **65%**.

A 12pm start was the most popular start time chosen by players with **34.3%** of votes. Furthermore, a 12pm start was the most popular choice in all age groups surveyed...

Even the majority of Saturday morning workers want change, with 51% also wanting to see an earlier start time (this figure rises to 82% in the under 30s age group).

Adopting a 12pm start time would also have the added benefit of guaranteeing a finish at, or before, 6.30pm, which is something that is wanted by **70**% of players.

<u>Vote</u>: Clubs are asked to endorse the preferences expressed by the players and agree to trying a 12pm start time.

CPCC Proposal 2: 'Endorsing The Player Survey' – Earlier Start Time (Divs 1-7)

THIS PROPOSAL IS TO BE REMOVED AT THE AGM IF THE PREVIOUS 12PM START TIME PROPOSAL (CPCC PROPOSAL1) HAS ALREADY BEEN APPROVED AT THE AGM.

The recent player survey indicated that <u>only 12%</u> of players want to start at 1.30pm (or later). Nearly ¾ of players (73%) under 45 want to start <u>no later than 12.30pm</u>. This figure rises to 78% among the under 30s.

Clubs are asked to vote for change and give the players what the vast majority of them want.

<u>Stage 1 Vote:</u> Are clubs willing to endorse the wishes of the players and move to an earlier start time? If a **YES** majority then move to Stage 2 Vote below. If a **NO** majority, then 1.30pm start time remains. End of Vote.

Stage 2 Vote: A significant majority of players want to start no later than 12.30pm. Are clubs willing to adopt a 12.30pm start?

If a NO majority, then move to Stage 3 Vote. If a YES majority then a 12.30pm start is approved and vote ends.

Stage 3 Vote: Do clubs want a 12.45pm start or 1pm start?

Majority established, new start time approved, vote ends.

<u>CPCC Proposal 3: 'Endorsing The Player Survey' – Move to 40 Overs (Divs 1-7)</u>

In the recent player survey, a 40 overs per side format was the most popular choice of players with 40% of votes.

A 40 over format would shorten the game slightly and help ensure an earlier finish (which is wanted by **70**% of players). Player participation is falling dramatically year-on-year with the current 46 over format and surely change is worth trying before it is too late.

A slightly shorter 40 over format (hopefully coupled with an earlier start and finish time) may prove a more attractive offer and help bring returning players back to the game, whilst also attracting new players. The slightly shorter format may also help the transition of junior players into senior cricket.

<u>Vote:</u> Clubs are asked to give the players the game format that was the most popular choice in the recent survey and agree to 40 overs per side.

<u>CPCC Proposal 4: Change to the Tea Rule (8.3.3) to Allow Clubs More Choice</u>

The player survey highlighted that 55% of players think teas should be mandatory. However, a considerable portion (45%) do not think they should be mandatory, or do not want teas at all. Is it right to continue to force tea costs and commitments upon clubs when 45% of players do not think they should be mandatory? The proposed amendment to rule 8.3.3 below is intended to provide a simple 'opt-in' / 'opt-out' solution that would allow home clubs that enjoy putting a tea on to continue to do so, while also allowing clubs who want to reduce tea costs the chance to do so. The wording has been written in the hope of providing a fair and sensible compromise for clubs.

PROPOSED AMENDED RULE 8.3.3

- (i) **The Provision of Teas** To allow clubs choice, the BDCL will operate a simple 'opt-in' or 'opt-out' system for match day teas. By default, all clubs will 'opt-in' to the provision and receipt of teas. To be allowed to 'opt-out' of teas, a club must notify the league in writing by **dd-mmm** of the forthcoming season. Unless a club has formally requested to 'opt-out' of teas (see 8.3.3(ii)), every home club is obliged to provide a tea for it's own players, scorer and each umpire. If their match day opponents are also an 'opt-in' club then the home club is also obliged to provide twelve teas for the visitors who should pay for eleven, the twelfth being a complimentary tea for their scorer. The LMC requests that the charge levied on the visiting team should not exceed £38. If the match day opponents are an 'opt-out' club, then no teas are provided to the visiting players (and scorer) and no levy will be applicable.
- (ii) Clubs who 'opt-out' of Teas Clubs that have formally requested to 'opt-out' of teas will be listed in the handbook (see 8.3.3 (iii)). Any club listed as an 'opt-out' club will not be required to provide a tea to any home player, away player, umpire or scorer at any of their home BDCL fixtures, nor will they receive or be required to pay for a tea at any of their away BDCL fixtures.

It shall be every clubs responsibility to check the handbook and be aware of whether their opponents are an 'opt-out' club.

<u>All</u> clubs (including those opting out of teas) should ensure hot and cold drinks are available free of charge to players, umpires and scorers.

Vote: Will clubs support this compromise and agree to adopt the proposed 'optional teas' rule?

<u>CPCC Proposal 5: New Win / Lose Points System – Scrapping Draws</u>

The recent survey indicated that 77% of players want to scrap the draw.

<u>Stage 1 Vote</u> - Are clubs willing to endorse the wishes of the majority of players and agree to scrap draws? If a YES majority, move to Stage 2 Vote. If a NO majority, existing scoring method remains.

Stage 2 Vote - Would clubs like to trial either OPTION A or OPTION B (both outlined below)?

OPTION A: WIN / LOSE + 'Bonus' Points

3 points for the winning side | No drawn outcomes | 1 point for an abandoned/cancelled game | 2 points for a tie | 1 'bonus' point available*

*1 'bonus' point will be awarded to the losing team if in the 2nd innings of the game they i] score 90% of what the winning team scored (e.g. if the winning team scored 190 batting first, then the opposing team would receive 1 point if, in losing the game, it scores 171 or more); or ii] get within 2 wickets of victory (e.g. have their opponents 8 wickets down at the time of defeat (or 7 down if their opponents only have 9 men, etc.)).

Where a game is abandoned in the 2nd innings, 1 'bonus' point will be awarded to the batting side if it has reached 90% of its opponents total at the time of abandonment, and to the bowling side if it is within 2 wickets of victory (Example scenario 1 - Team A score 201. The game is abandoned in the second innings with Team B 181-8. Both teams would earn 1 'bonus' point (2 points each in total). Example scenario 2 - Team A score 158. The game is abandoned in the second innings with Team B 120-6. Both sides finish with 1 point each as neither has met the criteria for a 'bonus' point to be awarded). No bonus points are available in the 1st innings of any game or any tied game (both sides earn 2 points in a tied outcome).

OPTION B: WIN / LOSE

3 points for the winning side | No drawn outcomes | 1 point for an abandoned/cancelled game | 2 points for a tie

<u>CPCC Proposal 6: Rule 3.4 – Dealing with Delayed Games</u>

This proposal is to seek approval from clubs for the LMC to evolve current Rule 3.4 relating to *Matches Delayed at the Start or Interrupted by Weather, Light or Unforeseen Circumstances.* Currently this rule states that "no match shall be reduced to less than 80 overs (Championship) or 72 overs (Division 1-7) scheduled at 40 overs (Championship) or 36 overs (Division 1-7). (Rule 3.4.2)"

This proposal would like to reduce this figure to 20 overs to allow more chance for teams to complete a full game.

Furthermore, it is requested that the LMC also look at other ways that can help improve the match day experience on weather affected days. Specifically, it is suggested that where rain is highly likely, both captains could agree, before the start of the game, to play a shorter format (choice of 35, 30, 25 or 20 overs per side) to help manage and lessen the impact of potential rain interruptions.

Vote A: Are clubs happy for the LMC to reword the necessary aspects of rule 3.4 to allow a reduction from 36 to a 20 overs per side contingency on rain affected days?

Vote B: If YES to the above, are clubs also happy for the LMC to incorporate new wording into the rule that, where both captains agree, a shorter format game of 35, 30, 25, or 20 overs per side could be played?

<u>CPCC Proposal 7: Rule 2.6.3 – Scrap the loss of a point for no scorer</u>

In 2019 the BDCL introduced a 1 point penalty for Championship and Division 1 sides for every match day where they did not have a scorer (rule 2.6.3). This rule is too penal and it is a kick in the teeth for players who work hard to earn points, only to see them removed for administrative reasons that are often beyond their control.

Vote: Clubs are asked to support the scrapping of the 1 point deduction for not having a scorer

CPCC Proposal 8: The 'Give Players More Choice' INVITATIONAL Proposal

THIS PROPOSAL IS SUBJECT TO THE OUTCOME OF THE PROPOSALS REGARDING START TIMES AND GAME OVERS AND MAY BE REMOVED BY THE PROPOSERS.

The player survey highlighted that different players want different formats and start times. This proposal would like to ask if any clubs would volunteer to trial an experiment and enter a team(s) into a stand-alone new BDC league branded as the BDCL **SLAM40**. Games would start at 12pm and be 40 overs in duration. The experiment would be reviewed at the end of the 2020 season at which point, if deemed successful, additional teams could request to enter a team for 2021. The aim would be to play a 20 or 22 game season as normal.

The experiment would give players choice and has 2 key benefits – firstly, it would be voluntary and **not** mandated upon any clubs i.e. all teams/players who want to carry on playing 46 over cricket can do so. Secondly, it allows those who are desperate for an earlier start and slightly fewer overs, the chance to play the format that they want also. Having a choice gives us a chance of keeping all players happy. The new format could bring a fresh new brand to the BDCL and teams entering would be encouraged to have T20 style variations on their names. As proposers, Clumber Park CC would be willing to enter one of it's 3 XIs into the SLAM40 (as the Clumber Cobras) and would like to ask if any other clubs would like to join them in trialling the league for the 2020 season.

Vote: In principle, would any clubs be interested in entering a team into the BDCL SLAM40 trial league?

*Exact rule tweaks would need to be confirmed but possible rules could be something like: 3 points for win, no draws, 1 bonus point criteria, fielding radius, 8 or 10 over bowling limit?



Proposals for changes to rules and format of cricket in BDCL for 2020

Clubs are reminded that all proposals need to be seconded at the AGM before any vote can be taken. Many of these proposed changes were discussed at the Pre-AGM in October. Clubs are asked to discuss these proposals with their players so those attending the AGM can vote having a mandate from their players. There will be a time limit allocated for discussion of these points at the meeting.

As is common practise, amendments to proposals will be voted on first. A straight majority in favour of a proposal is required for that proposal to be carried. No amendments can be offered at the meeting.

(1) LMC proposal in respect of start times

Matches in Division 1-7 (or lowest Division) - will commence at 1.00 pm. Matches in the Championship playing 50 overs will start 30 minutes earlier. In September all matches will start 30 minutes earlier (12.30 or 12.00 noon).

LMC Comment – it is very clear from the survey that players favour earlier start times. Should an earlier start time be agreed a reduction in playing overs may not be considered necessary to achieve the earlier finish times that players also favour; the LMC would still like the following proposal to be voted on.

3 LMC proposal for Win/Lose plus bonus points

DEFEATED (16/23)

The LMC acknowledges the players' views as indicated in the 2019 Player Survey and proposes a change in playing format to a Win/Lose with Bonus points to the losing team.

Proposed scoring of points for Win/Lose plus bonus points system

1. The side scoring the highest number of runs in their innings will be awarded twenty (20) points for a win.



- 2. In a match where the sides finish with equal scores (a tie), ten (10) points shall be awarded to each side.
- 3. Sides that receive points for a win or a tie shall not receive bonus points.
- 4. In all matches the side scoring fewest runs in a match will be awarded points for achieving the following targets: (50 overs/46 overs/40 overs) 1 point 140/120/100, 2 points 160/140/120, 3 points 180/160/140, 4 points 200/180/160; (all divisions) 1 point 3 wickets taken, 2 points 5 wickets taken, 3 points 7 wickets taken, 4 points 9 wickets taken.
- 5. In the event of a match being abandoned cancelled never started, each side shall receive eight (8) points.
- 6. In the event of an incomplete but started (weather affected) match where no result is possible despite best efforts see rule 3.4.3, each side shall receive six (6) points, **plus** any bonus points they have earned in the course of the match.
- 7. In the event of a delayed start reducing the total number of overs in a match, the threshold for batting bonus points shall be according to the number of overs scheduled at the revised start time and according to the table shown under rule 3.4.5.

4 LMC proposal for Loans or temporary transfers

CARRIED (31/4)
MAJORITY VOTE

- 1. Clubs will be able to register players on a temporary basis in order to avoid the cancellation of a fixture.
- 2. The maximum number of players transferring to a team must not exceed THREE in any one match
- 3. The player(s) involved in these transfers must be actively registered players with other clubs within the league.
- 4. The club requesting a loan player MUST ask his/her parent club for permission and the Registrar MUST be copied in this email.
- 5. All loan transfers must be submitted on Play-Cricket by MID-DAY on the day the match (where practicable).
- 6. The parent club would then apply on Play-Cricket to re-register the player back to them.
- 7. Within the temporary loan/transfer system, no player would be allowed to drop more than TWO divisions.
- 8. Only the lowest team within a club can sign loan players.
- 9. When registering a loan player on Play-Cricket the words 'Temporary Loan' must be added to the registration.
- 10. No temporary loan/transfer will be allowed after the third Saturday in August.
- 11. This will be reviewed after one season.



5 LMC Proposed new wording for Rule 3.4 to allow for longer delay and more reduced overs in the event of a delayed start.



NB overs table and bonus points table show for 50 overs, 46 overs and 40 overs depending on what is decided. Options not being played will not be published in the handbook. Changes shown in red.

- 3.4 Matches Delayed at the Start or Interrupted by Weather, Light or Unforeseen Circumstances
- 3.4.1 The number of overs shall be arranged so that both teams have the opportunity of batting for the same number of overs.
- 3.4.2 No match shall be reduced to less than *60 overs (Championship)* or 52 overs (Division 1-7) scheduled at *30 overs (Championship)* or 26 overs (Division 1-7).
- 3.4.3 If the team fielding fails to bowl the required number of overs within the re-calculated time allowance, the provisions in Rule 3.2.8 shall apply.

The calculations are shown as follows (Championship/Division 1-7):

The calculation of the time allowance with which to bowl the allocated overs is based on one over for each 3½ minutes, rounded up to the nearest minute where appropriate.

- 3.4.5 New table to be inserted here for runs required for bonus points see separate attached
- 3.4.6 If, after 2 hours has elapsed, or after the game has started, interference by weather, light or unforeseen circumstances amounts to more than 30 minutes, a time limit shall be applied from the time 5½ hours (Championship) or 5 hours (Division 1-7) after the scheduled start of play.
 - A match which is delayed for more than 2 hours after the scheduled start of play, but is able to start before 2 hours and 30 minutes after the scheduled start of play (2 hours and 50 minutes should an early tea be taken), will remain a reduced overs game scheduled at 30 overs (Championship) or 26 overs (Division 1-7) per team. The additional time lost (up to 30 minutes) will form part of the 30 minutes allowable before a time limit shall apply.
 - Should the interruption occur during the first innings, on resumption the batting side will be entitled to bat for the maximum allotted overs as scheduled at the start of play
- 3.4.7 When a time limit has been applied there shall, unless further interference occurs or the match is completed, be one hour's play or a minimum of 17 overs bowled.
- 3.4.8 If further interference occurs by weather, light or unforeseen circumstances when a time limit has been applied, or if time is lost during the last hour of play causes a time limit to be applied, the number of overs to be bowled on any resumption of play shall be reduced, from the total of 17, by one over for each full 3½ minutes which have elapsed after the scheduled commencement of the last hour.

During the last hour, the number of overs bowled prior to any interruption is not taken into consideration when working out the number of overs remaining. The calculation of the number of overs remaining is determined using the following table:

During the last hour, on resumption of play, any part overs count as a whole over. For example, if there are 8 minutes of playing time remaining and the bowler has 3 balls remaining of their current over. The minimum number of overs to be bowled will be 2.3 (and not 3).

⑤A Amendments to this proposal received from Clumber Park CC



Vote A: Are clubs happy for the LMC to reword the necessary aspects of rule 3.4 to allow a reduction from 36 to a 20 overs per side contingency on rain affected days?

Vote B: If YES to the above, are clubs also happy for the LMC to incorporate new wording into the rule that, where both captains agree, a shorter format game of 35, 30, 25, or 20 overs per side could be played?

It is requested that the LMC also look at other ways that can help improve the match day experience on weather affected days. Specifically, it is suggested that where rain is highly likely, both captains could agree, before the start of the game, to play a shorter format (choice of 35, 30, 25 or 20 overs per side) to help manage and lessen the impact of potential rain interruptions.

6 Proposal from Clumber Park CC in respect of provision of teas

PROPOSED AMENDED RULE 8.3.3

DEFEATED (5/33) MAJORITY VOTE

(i) The Provision of Teas — To allow clubs choice, the BDCL will operate a simple 'opt-in' or 'opt-out' system for match day teas. By default, all clubs will 'opt-in' to the provision and receipt of teas. To be allowed to 'opt-out' of teas, a club must notify the league in writing by dd-mmm of the forthcoming season. Unless a club has formally requested to 'opt-out' of teas (see 8.3.3(ii)), every home club is obliged to provide a tea for its own players, scorer and each umpire. If their match day opponents are also an 'opt-in' club then the home club is also obliged to provide twelve teas for the visitors who should pay for eleven, the twelfth being a complimentary tea for their scorer. The LMC requests that the charge levied on the visiting team should not exceed £38.



- If the match day opponents are an 'opt-out' club, then no teas are provided to the visiting players (and scorer) and no levy will be applicable.
- (ii) Clubs who 'opt-out' of Teas Clubs that have formally requested to 'opt-out' of teas will be listed in the handbook (see 8.3.3 (iii)). Any club listed as an 'opt-out' club will not be required to provide a tea to any home player, away player, umpire or scorer at any of their home BDCL fixtures, nor will they receive or be required to pay for a tea at any of their away BDCL fixtures.

It shall be every club's responsibility to check the handbook and be aware of whether their opponents are an 'opt-out' club.

<u>All</u> clubs (including those opting out of teas) should ensure hot and cold drinks are available free of charge to players, umpires and scorers.

(iii) The clubs listed below have formally chosen to 'opt-out' and do not provide or receive teas:

Vote: Will clubs support this compromise and agree to adopt the proposed 'optional teas' rule?

⑦Proposal from Harthill CC − Rule 2.6.3: Amendment of the rule to remove the necessity for Division 1 clubs to provide a scorer.

DEFEATED (13/18)
MAJORITY VOTE

MAJORITY VOTE 💢

Rationale: In the wort case of no scorer, players from each team doing the scoring and working with umpires has functioned without incident for many years. The necessity for a scorer adds further to the ever-escalating match day costs.

8 Proposal from Clumber Park CC – Rule 2.6.3: Remove the rule for both Championship and Division 1.
DEFEATED (10/26)

Rationale: This rule is too penal, and it is a kick in the teeth for players who work hard to earn points, only to see them removed for administrative reasons that are often beyond their control.

Note – the LMC does not support the proposal to remove the point deduction for no scorer in the Championship and Division 1. The LMC consider the scorer to be an integral part of the match and a required match official. All clubs are encouraged to support players and non-players who want to be involved as match officials.



9 Proposal from Harthill CC – Rule 3.5.1 Overs per bowler: Amendment of the rule back to the over allowances as they were prior to the 2019 season. In a 50 over game, this to be returned to the previous 15. In a 46 over game, this to be returned to the previous 13.

DEFEATED (16/23)

Rationale: The requirement for a 5^{th} bowler puts an added strain on clubs playing resources and typically weakens 2^{nd} teams when a player who would bowl a full spell in the 2^{nd} team is now playing 1^{st} team cricket to address the 5^{th} bowler requirement.

10 Proposal from Thoresby Colliery CC. Proposed change and simplification to rule 5.3.4 – changes shown in red

5.3.4. Remove all this rule and replace with:

Club Players (Category 1) may play for any team within a club but must only move down ONE team at a time (i.e. NOT 1st to 3rd, 2nd to 4th).

However, after the Third Saturday in August, player may only play for a lower team if they have already done so during the season.

Category 2 and 3 Players must only play for a club's 1st team.

Explanation: This change basically extends the present rule, and gives clubs more selection choices (loss of form, work issues etc) 'Get the Game On'

(11) Proposal from NOMADS CC. Proposed changes to rule 5.3.4 – changes shown in red

Player Eligibility



- 5.3.4.1 On all dates, no player shall be eligible for a team more than one lower than that for which most, or equal most, appearances have been made during the current season. A player should only play for a lower team if their higher team is still able to field a team of 11 players.
- 5.3.4.2 Additionally, in a fixture played after the third Saturday in August, on a Bank Holiday Monday, on a Sunday, or any other date that a more senior team has no fixture, or a



fixture cancelled, a player who has played the majority of their matches at a higher level than the match being played, or a player who has not played a match within the BDCL during the current season, shall not be eligible to play.

This shall not apply to fixtures up until the first Saturday in June. In addition, no player shall play down more than 3 divisions e.g. Division 2 to 5, but not 6.

NOTES ON THE ABOVE RULES

- 5.3.4.1 The 1st part of the rule applies all season and restricts players from dropping down by more than one team (i.e. 1st to 3rd, 2nd to 4th etc.). Players have to move down 1 team at a time (i.e. 1st to 2nd to 3rd etc.).
- 5.3.4.2 The second part of the rule adds extra restrictions after the 3rd Saturday in August, non-Saturday fixtures, when a higher team has no scheduled fixture and when a higher team has a fixture cancelled. This part of the rule restricts teams from artificially inflating lower teams when players from higher teams are or become available.

This part of the rule will not apply until the first weekend of June in order to allow for players to 'find their level'. The first part of the rule remains. Clubs found in abuse of this allowance will receive the sanction as advised under Rule 5.6.2.

This part of the rule states that any player that has only played for a higher team is not eligible to play for a lower team. For example, players that have only played for a club's 1st XI would not be eligible to play for any of the club's other teams.

The same applies to players that have only appeared for both a clubs' 1st/2nd XI as they would be ineligible for a clubs' 3rd XI.

Under this part of the rule, where a player has played for a clubs' 1st and 2nd XI they are eligible to continue to play for both the 1st and 2nd XI. Where a player has played for all a club's teams, the player would be eligible to play for any team, as long as they do not go from 1st to 3rd team (would have to go 1st to 2nd to 3rd).

5.3.5 Any such breach may result in the player(s) being deemed as ineligible and the sanction as advised under Rule 5.6.2 may apply.

Clubs are asked to consider the Spirit of Cricket (see rule 7.4.2) and the need to 'Get the Game On' when making a complaint under this rule.

Rationale:

- 5.3.4.1 this addition is implicit anyway but makes it explicit.
- 5.3.4.2 it is important to realise that this rule ONLY applies in situation where a higher team does not have a fixture, except in the last 2 or 3 weeks of the season where promotion or relegation is on the line.

Adding the phrase "the majority of matches" rather than all matches, strengthens the rule.

Adding that in these circumstances, no player shall play down more than 3 divisions, strengthens the rule.

By removing the clause that "This shall not apply to fixtures up until the first Saturday in June" the rule is both simplified (this is the biggest cause of confusion) and strengthened. Near in mind that this part of the rule only applies in very limited circumstances. Players



can still "FIND THEIR LEVEL" under Rule 5.3.4.1 when all teams have a fixture on any Saturday before the end of August.

Proposal from Clumber Park CC – 'Give Players More Choice' Invitational Proposal

NOT VOTED ON (NO SECONDER)

The player survey highlighted that different players want different formats and start times. This proposal would like to ask if any clubs would volunteer to trial an experiment and enter a team(s) into a stand-alone new BDCL branded as the BDCL SLAM40. Games would start at 12pm and be 40 overs in duration. The experiment would be reviewed at the end of the 2020 season at which point, if deemed successful, additional teams could request to enter a team in 2021. The aim would be to play a 20 or 22 game season as normal.

The experiment would give players choice and has 2 key benefits – firstly, it would be voluntary and not mandated upon any clubs i.e. all teams/players who want to carry on playing 46 over cricket can do so. Secondly, it allows those who are desperate for an earlier start and slightly fewer overs, the chance to play the format that they wat also. Having a choice gives us a chance of keeping all players happy. The new format could bring a fresh new brand to the BDCL and teams entering would be encouraged to have T20 style variations on their names. As proposers, Clumber Park CC would be willing to enter one of its 3 XIs into the SLAM40 (as the Clumber Cobras) and would like to ask if any other clubs would like to join them in trialling the league for the 2020 season.

VOTE: In principle, would any clubs be interested in entering a team in the NDCL SLAM40 trial league.



ADDITIONAL INFORMATION

Revised tables for rule 3.4 NB Tables includes option for both 46 and 40 overs in other than the Championship THIS WILL BE AMENDED AFTER THE AGM WHEN THE NUMBER OF OVERS IN THE LOWER DIVISIONS IS DECIDED.






