## **2. ACCEPTANCE OF MINUTES FROM THE PREVIOUS MEETING**

The minutes of the meeting held on **Tuesday 17 March 2020** and subsequent virtual Referral Committee meetings held since were accepted as a true and accurate record of proceedings.

## **3. MATTERS ARISING FROM THE PREVIOUS MEETING**

### **3.1 County Disciplinary Forum / League Disciplinary Rules.**

AW confirmed there had been no further meetings to discuss this matter during the lockdown period.

However, this matter is now at the forefront and it has been agreed by all parties that it would be appropriate to discuss and conclude this matter ready for implementation by the leagues during the 2021 season. It was also agreed that the final arrangements should be in place ready for discussion at forthcoming league AGM's.

Andrew Wilson, Joe Fish and Josh Scully are progressing this matter.

### **3.2 Umpires Refresher Training Courses.**

IR reported that the Stage 3 course scheduled to take place in March 2020 had been cancelled. It had been intended to move this to October 2020, but this has not been possible. No face to face training will take place this year.

There are no further updates on Stage 2 courses.

## **4. FINANCE & SPONSORSHIP**

### **4.1 Management and development of the league web site has now been taken back in house. TM reported that the final monthly payment has now been made to Brand Savvy (formerly B4-6 IT) as our contract with them for web site services has now been terminated.**

TM reported an anticipated balance of £5.5 - £6k at the end of the current financial year.

The reformation of the league sponsorship committee was discussed; however, this has been placed in abeyance as it was felt that it would be difficult to attract significant sponsorship considering the current economic situation.

Andrew Wilson has sent details of the ECB Return to Cricket Grant Scheme for the LMC to consider whether it wishes to apply for a grant. This is to cover expenses, not loss of anticipated income; and grants of £500 - £3000 are available.

## **5. CHILD WELFARE AND DBS MATTERS**

- 5.1 AW reported that all child welfare matters are now being dealt with by Graham Redfern. who has returned to work, Josh Scully has also now returned to work part time and is able to assist Graham where necessary.

The cricket development officers have covered child welfare matters whilst other members of cricket office staff have been on furlough leave; and they have full access to the DBS database. DBS verifications can now be carried out 'face to face' with social distancing.

AW added that there were no immediate concerns for our league.

CWO training courses have been shelved during the lockdown period, although the ECB have provided some on-line options.

## **6. CORRESPONDENCE**

- 6.1 NF reported receipt of an e-mail from Trevor Haywood regarding storage of unused/redundant league trophies.

Trevor has a significant number of trophies stored at his home and asked that the LMC consider if they wish to use these, reallocate them or dispose of them.

A list of all trophies is appended, those currently retained by Trevor are highlighted.

It was noted that trophies are required for the batting and bowling awards for Divisions 2,4 and 6.

It was also agreed that TH would be asked to contact Richard at SB trophies to enquire whether he would be willing to store the trophies on behalf of the league.

- 6.2 Presentation of 2020 trophies. It was agreed that although Thoresby Colliery CC had provisionally agreed to hold a 'condensed' presentation evening at the end of the season, the LMC declined this kind offer.

Arrangements will therefore be made for trophies to be presented by a member of the LMC at each of the end of season 'sub-division' winners play off fixture.

- 6.3 Wilkinson Trophy for outstanding services to a club. This matter was discussed at length and the 2020 winners agreed upon by the LMC.

It was also agreed to invite the winners as guests of the league to an end of season play off fixture where the trophy will be presented.

- 6.4 2020 Mallen Trophy competition. Following observations received from league clubs regarding player eligibility, a thorough review was undertaken of the scorecards from the fixtures identified.

Consequently, the results from the following matches were overturned:

Welbeck CC v Cavaliers & Carrington CC (19 July 2020), original result overturned and points awarded to Welbeck CC.

Welbeck CC v Notts & Arnold CC (02 August 2020), original result overturned and points awarded to Welbeck CC.

Cavaliers & Carrington CC v Thoresby Colliery CC (09 August 2020), original result overturned and points awarded to Thoresby Colliery CC.

The impact of these decisions on final Mallen Trophy league table placings will be considered once all the group fixtures have been completed.

## **7. CLUB CONSULTATION PLANS 2020 (RULES COMMITTEE)**

7.1 SR reported that due to the current circumstances the rules committee had not met during 2020.

It was agreed to look at the format of the rules committee going forward and involve more current players if possible.

7.2 Following the different playing format and rules used in the shortened 2020 season, a questionnaire will be composed and sent to all clubs (for distribution to as many players as possible) to gauge their opinions on the changes and whether some of these should be adopted by the league going forward.

## **8. ANY OTHER BUSINESS**

8.1 Scoring and score card entries. The scorecards entered by teams onto play cricket are being checked rigorously.

Members of the LMC carrying out this process are in regular contact with league clubs where there are instances of missing information ('Unsure players', unsure catchers, totals not adding up etc) so that the correct information can be entered or other errors corrected in a timely manner and scorecards can be locked.

The LMC appreciate that scoring and retaining competent scorers remains an issue for many clubs and will look to provide further guidance and details of resources and training courses over the forthcoming months.

8.2 Covid 19 precautions. The LMC had been made aware of number of recent incidents reported from leagues around the country, including fixtures being suspended because of the failure of several clubs to adhere to ECB guidance.

Compliance in our league has generally been good, although there have been several incidents reported where hygiene breaks have not been taken at the correct intervals or not at all.

Ian Rich reminded everyone of the importance of adhering to the Covid 19 precautions, and BDUA umpires will continue to ensure that ball sanitisation breaks and other recommended measures are carried out in full accordance with current ECB and Government guidance.
